SECTION 3 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

Flammable liquid. Contains methanol and ethylene glycol, harmful if swallowed. Product cannot be made non-poisonous. Contact with skin and eyes may cause irritation. Hazard symbols for this product - F, T. Risk Phrases - R10, 23/24/25, 39/23/24/25

POTENTIAL HEALTH EFFECTS

INHALATION: High concentrations are irritating to the respiratory tract; may cause headache, dizziness, nausea, vomiting, malaise, blurred vision, blindness, coma and death.

SKIN: Brief contact may cause slight irritation; prolonged contact may cause moderate reddening, swelling and possible necrosis.

EYES: Contact causes severe irritation and pain associated with redness and swelling of the conjunctiva.

SECTION 4 - FIRST AID MEASURES
